

Streamlyne Wellness & Safety Plan - Streamlyne UP! 2021

Although the ultimate decision of whether to attend the Streamlyne Up! event is in the hands of each individual, please know that Streamlyne has undertaken measures towards providing a safe and welcoming environment for all onsite participants. As such, we have enacted COVID-19 safety protocols based on current guidelines recommended and required by the City and County of San Diego, and by the CDC, which are currently as follows:

Registration

All in-person participants must register in advance. We will not provide on-site registration for this year's Streamlyne Up! event.

Throughout the event, we will ensure the meeting venue has appropriate physical capacity to accommodate adequate social distancing. The conference venue will have a capacity limit that is strictly enforced. Participants will be asked to not stand in the back of a room, bring chairs in from other locations, sit on the floor of a room, or congregate in indoor hallways outside of presentation and meeting areas. It is recommended that individuals maintain adequate distance between themselves and others at all times.

In-person attendance

The current Health Order, issued by the County of San Diego includes the following requirements and restrictions. Additionally, the California Department of Public Health has standing orders designed to inhibit the transmission of COVID-19. As of this moment, Streamlyne, the event venue, the hotel, and local businesses are bound by these orders:

1. Currently the California Department of Public Health **recommends** universal masking indoors, regardless of vaccination status.
2. Masks are **required** on public transit and in transit hubs. Public transit includes airplanes, ships, ferries, trains, subways, buses, taxis, and ride-shares. Transit hubs include airport, bus terminal, marina, train station, seaport or other port, subway station, or any other area that provides transportation
3. Masks are **required** for all unvaccinated individuals in indoor public settings and businesses. This includes retail, restaurants, theaters, family entertainment centers, meetings, state, and local government offices serving the public.
4. Venue operators **may choose to:**
 - a. Provide information to all patrons, guests and attendees regarding vaccination requirements and allow vaccinated individuals to self-attest that they comply prior to entry.
 - b. Implement vaccine verification to determine whether individuals are required to wear a mask.
 - c. Require all patrons to wear masks.
5. You are required to isolate immediately under the following circumstances:
 - a. You have a positive COVID-19 test.

- b. You have signs and symptoms of COVID-19, which include cough, shortness of breath, trouble breathing, fatigue, fever or chills, body or muscle aches, a sore throat; a new loss of taste or smell, congestion, runny nose, nausea, vomiting or diarrhea.
 - c. A physician has informed you that you are likely positive for COVID-19
6. In the unlikely event of isolation, you agree to follow the isolation requirements at the time of the incident, with current requirements found here:
